# TEWKSBURY TOWNSHIP ENVIRONMENTAL COMMISSION MINUTES January 13, 2014

The Tewksbury Township Environmental Commission met at a regular meeting on the above date in the Municipal Meeting Hall, 60 Water Street, Mountainville, New Jersey. The meeting was called to order at 7:40 p.m., roll call taken and a quorum established.

## OPEN PUBLIC MEETINGS ACT

Chris Teasdale announced that adequate notice of the meeting had been provided by posting a copy thereof on the Municipal Building bulletin board, mailing a copy to the Hunterdon Review and the Hunterdon County Democrat, and filing with the municipal clerk, all on December 16, 2013.

Those members that were re-appointed read and signed their Oaths of Office. Discussion ensued regarding the membership of the Board and how members move from Alternate to regular members.

Mr. Teasdale opened the meeting up to the public. There being no one in the audience, Mr. Teasdale closed the public participation portion of the meeting.

Mr. Teasdale noted that Ms. Goodchild confirmed that the Township has committed to tackling the water chestnut issue with herbicides for the next few years. Mr. Teasdale opined that the Commission's role should be to monitor and document the process. When asked when the first application of herbicide will be, Mr. Teasdale explained that it will be spring but he is unsure of the exact date.

## **DISCUSSION ITEMS**

Updates – Land Use Board

Mr. Mackie noted that the Land Use Board re-organized last week. He announced that the cell tower hearing has been postponed until February 5, 2014 as the applicant did not have enough time to update the plans and reports.

Mr. Mackie noted that there was an informal discussion by the Oldwick General Store regarding the vacant office on the second floor; there may be a future application to request a change from an office to an apartment.

#### ➤ Miscellaneous

Noting that the Commission did a great job with getting a handle on the water chestnut issue, Mr. Teasdale asked the members if there were any other projects or concerns for the Commission to discuss or look into during 2014.

Discussion ensued regarding the data from the annual water test results. Mr. Mackie noted that the watershed is working on a database and agreed to check on the status.

Mr. Colitti noted that lead in the water at the Old Turnpike School has been a problem for years and the school children can't even drink the water in the fountains. Mr. Mackie opined that it was the pipes and not a well issue. Mr. Colitti questioned why the Commission was never involved in that issue. Mr. Teasdale speculated that the Township has always tried to keep out of the schools business and leave it to the Board of Education. Conversely, Mr. Colitti noted that the well water at the Tewksbury Elementary School is some of the best water he's tasted.

Mr. Teasdale indicated that he plans to show the Township Committee the i-movie at an upcoming Township Committee meeting.

## **ADJOURNMENT**

There being no further business, Mr. Mackie made a motion to adjourn at 8:30 p.m. Mr. Stein seconded the motion. All were in favor.
